This is an Agreement between MALBRIG & Associates, Inc. dba as Happy Camper Doggy Day Camp (HCDC) and the Owner/Guardian whose name is \_\_\_\_\_ and whose signature appears on page 2. Following are the terms of service for doggy day camp and/or sleepover of the Owner/Guardian's pet (name) \_\_\_\_\_

1. By signing this Agreement and leaving your pet with HCDC, Owner/Guardian certifies to the accuracy of all information provided to HCDC in writing or orally about pet.
2. Owner/Guardian agrees to pay the rate for day camp and/or sleepover in effect. Additional pets from same household will be charged an additional daily rate. No day camp/sleepover pet will be released until all charges are paid in full. Owner/Guardian shall remain liable for complete day camp/sleepover bill as well as charges incurred in the care, maintenance and disposal of said pet as listed in this contract.
3. Owner/Guardian specifically represents to HCDC that, to Owner/Guardian's knowledge, the pet has not been exposed to any contagious diseases within a 30-day period prior to Camp check-in. Owner/Guardian understands that each time pet is brought to HCDC, they are re-certifying that the pet is in good health and has not had any communicable illnesses of any kind for 30 days prior to check-in.  
 NOTE: Owner/Guardian acknowledges and is aware that vaccines do not protect against all communicable illnesses that may affect a camper.
4. All dogs must be current on the following vaccinations: distemper, parvo, bordetella, and rabies. Valid proof of vaccinations must be presented before pet can be dropped off for day camp or sleepover.

### 5. Assumption of Risk

Happy Camper Doggy Day Camp agrees to exercise due and reasonable care during your pet's day camp and/or sleepover stay and if applicable during transport. If a pet is transported to or from HCDC by HCDC staff, Owner/Guardian agrees to hold HCDC and its staff harmless in the event of an injury or accident during transport. All pets are handled and cared for by Happy Camper staff without liability on HCDC's part for loss or damage from disease, theft, fire, escape, injury or other harm to persons, other pets or property by said pet or from unavoidable causes, due diligence and care having been exercised.

Owner/Guardian acknowledges and agrees that they are assuming all risks of illness, disease, harm or otherwise to their pet by allowing their pet to attend camp or sleepover at HCDC location. It is expressly agreed by Owner/Guardian and Happy Camper Doggy Day Camp that Happy Camper Doggy Day Camp's liability in no event shall exceed \$200 which is the current tangible value of a pet of the same breed per animal admitted.



6. Owner/Guardian understands that HCDC utilizes playgroups where dogs interact and co-mingle with other dogs. Owner/Guardian agrees that their dog(s) may be removed from a playgroup at HCDC's discretion for aggressive behavior. Owner/Guardian further understands that when dogs play in groups, cuts, nicks, scratches may occur. **HCDC's policy is to inform Owner/Guardian of any and all minor cuts, nicks and scratches either by phone during day camp hours or when pet is picked up.**
  
7. In an emergency, Happy Camper Doggy Day Camp will attempt to contact the pet's Owner/Guardian; however such an emergency might not provide time to do so prior to the administration of care. Owner/Guardian authorizes HCDC to obtain medical attention for pet from pet's veterinarian or HCDC's on-call veterinarian or emergency veterinarian hospital and to transport the pet to and from veterinarian when HCDC deems such medical care is important to pet's health. Owner/Guardian grants HCDC and its employees full authority to make decisions involving medical treatment of pet and agrees to pay for related costs. This applies to any claims for injuries or damages related to such medical care or that arise due to the transport of the pet. In the event of a pet's death, the Owner/Guardian's emergency contact will be notified immediately.
  
8. Owner/Guardian agrees to hold MALBRIG & Associates, Inc. DBA Happy Camper Doggy Day Camp, its directors, members, officers and lessor of the property and any employees of the aforementioned parties, harmless from any and all claims for loss or injury which may be alleged to have been caused directly or indirectly to any person, or thing by the act of my dog and Owner/Guardian personally assumes all responsibility and liability for any such claim. Owner/Guardian assumes sole responsibility for and agrees to indemnify and save the aforementioned parties harmless from any and all loss of expenses (including legal fees) by reason of liability imposed by law. Owner/Guardian will not charge HCDC or its representatives with punitive damages. Owner/Guardian certifies that they are the actual owner of the pet and duly authorized agent.
  
9. Owner/Guardian agrees that their pet may be videotaped, photographed and recorded. HCDC shall be the exclusive owner of the results and all proceeds of such tapings, photography and recordings with the rights, throughout the world, an unlimited time in perpetuity, to copyright, and to license to others to use in any manner. The Owner/Guardian further agrees that their pet(s) may be used in all media and in the promotion, advertising, sale, and publicizing of the Happy Camper Doggy Day Camp and SleepOver.
