Terms and Conditions

Please read carefully, this agreement is a release, waiver of liability, assumption of risk and indemnification agreement entered into by and between MALBRIG & Associates, Inc. d/b/a Happy Camper Doggy Day Camp & SleepOver ("HCDC") and the dog owner ("Owner") listed on the "Service and Enrollment Application" sheet, as of the date this Agreement signed by the Owner (the "Effective Date"). Wherefore the dog(s) identified on the "Service and Enrollment Application" sheet (the "Dog") will: attend the HCDC doggy day camp, HCDC sleepover, and/or receive others services from HCDC (i.e. bathing, etc.) identified herein are collectively referred to as the "Services"). Collectively the Owner and HCDC are each referred to as a Party and collectively as the Parties. Wherefore the Parties agree that the terms stated within this Agreement shall govern the Services provided.

1. Term and Termination. This Agreement shall begin on the Effective Date and shall remain in effect until terminated in writing by either Party.
2. Payment. Owner agrees to pay HCDC for the Services provided. Additional dogs from the same household will be charged an additional daily rate. Owner may be charged additional fees if HCDC must provide food, medicine, etc. that were not provided at the time of drop-off. PAYMENT IS DUE PRIOR TO PICK-UP OF THE DOG(S) AND HCDC RESERVES THE RIGHT TO REFUSE TO PROVIDE FUTURE SERVICES UNTIL ALL CHARGES AND PAYMENTS ARE PAID IN FULL. Owner shall remain liable for the complete bill as well as charges incurred in the care, maintenance and disposal of the Dog as listed in this Agreement. HCDC reserves the right, without notice, and its sole and absolute discretion to adjust its fees for services. Owner will be assessed a late fee on any outstanding balance in the amount of the lesser of: one and one-half percent (1.5%) or the highest rate allowed by law.
3. Unclaimed-Abandoned Dogs. ANY DOG(S) LEFT FIVE (5) DAYS BEYOND THE AGREED PICK-UP DATE WILL BECOME PROPERTY OF HCDC AND MAY BE PLACED/DISPOSED AT HCDC'S DISCRETION.
4. Photographs. Owner agrees that the Dog may be videotaped, photographed and recorded. HCDC shall be the exclusive owner of the results and have the rights to all proceeds of such tapings, photography and recording. HCDC shall have the perpetual rights to copyright and to license any videos, photographs and recordings to others to use in any manner. Unless Owner provides written notice to HCDC indicating otherwise, Owner further agrees that their Dog may be used in all media, including social media, and in the promotion, advertising, sale, and publicizing of HCDC.
5. Standard of Care. HCDC represents that the Services provided under this Agreement will be performed in accordance with industry standards for similar services. HCDC will use reasonable efforts to accommodate the needs each Dog. Owner understands and acknowledges that while HCDC is in possession of the Dog, HCDC may need to make judgment calls regarding the health, welfare, and safety of the Dog. HCDC will use reasonable care when making such judgements.
6. Warranty of Authority. Owner represents that it has the authority in regards to the Dog to enter into this Agreement, and that there are no other agreements or written or oral understandings with any third party that interferes with or restricts HCDC's ability to perform the Services, or for HCDC to be in possession of the Dog.
7. Modifications & Special Instructions. To avoid any miscommunications regarding care for the Dog, any modifications to this Agreement must signed and approved by Mary Beth Albright in writing to be considered approved by HCDC. If there are special instructions regarding care for the Dog, these instructions must be submitted in writing to HCDC. To ensure specific care, oral instructions are not deemed sufficient.
8. Miscellaneous.
 - a. Governing Law and Venue. This Agreement is governed by the laws of the state of Florida and venue for any disputes will be in the court of record in Pinellas County, Florida. In the event that Owner or HCDC wish to file suit under this Agreement, prior to filing both Parties agree that they will attend at least four (4) hours of pre-suit mediation. The cost for the mediation will be split between Owner and HCDC.
 - b. Limitation of Liability. IN NO EVENT SHALL HCDC BE LIABLE FOR LOSS OF GOODWILL, OR FOR SPECIAL, INDIRECT, INCIDENTAL, CONSEQUENTIAL, PUNITIVE, EXEMPLARY, OR TORT DAMAGES ARISING OUT OF OR RELATING TO THIS AGREEMENT, REGARDLESS OF WHETHER SUCH CLAIM ARISES IN TORT, CONTRACT, OR OTHERWISE. NEITHER PARTY MAY ASSERT ANY CLAIM AGAINST THE OTHER RELATED TO THIS AGREEMENT MORE THAN ONE (1) YEAR AFTER SUCH CLAIM ACCRUED. HCDC AGGREGATE LIABILITY TO OWNER AND ANY THIRD PARTY FOR ANY AND ALL CLAIMS OR OBLIGATIONS RELATING TO THIS AGREEMENT OR THE DOGS IDENTIFIED WITHIN THIS AGREEMENT SHALL BE LIMITED TO THE TOTAL FEES PAID BY OWNER TO HCDC UNDER THIS AGREEMENT RESULTING IN SUCH LIABILITY IN THE THREE (3) MONTHS PERIOD PRECEDING THE DATE THE CLAIM ACCRUED. IT IS EXPRESSLY AGREED BY THE OWNER AND HCDC THAT THE CURRENT TANGIBLE VALUE OF A DOG IS \$200.
 - c. Cost of Collections. Owner shall be responsible to HCDC for any and all costs of collections related to the unpaid Services or monies owed in connection with this Agreement (i.e. monies due to third-party service providers for care rendered to the Dog while the Dog was in HCDC's possession.)

- d. Waiver, Severability, & Survival. No provision of this Agreement shall be deemed waived, unless such waiver shall be in writing and signed by the party against which the waiver is sought to be enforced. The waiver by either of the parties hereto of any breach of any provision hereof by the other party shall not be construed to be either a waiver of any succeeding breach of any such provision or waiver of the provision itself. Should any term of this Agreement be found invalid or unenforceable, it shall not affect the validity or enforceability of any other term of this Agreement. Any provision of this Agreement that imposes an obligation after termination or expiration of this Agreement shall survive the termination or expiration of this Agreement.
- e. Assignment. HCDC may assign or subcontract this Agreement or any of their obligations under this Agreement upon written notice to Dog's Owner. The rights and obligations of each party under this Agreement shall inure to the benefit of, and be binding upon, the legal representatives and permitted successors and assignees.

HCDC reserves the right to immediately change the type of Service for the Owner's Dog if we believe it is necessary to protect the health and well-being of Owner's Dog, other dogs, or our staff.

<u> </u> Initials	Owner acknowledges and understands that there are certain risks involved in performing the Services identified within this Agreement, including but not limited to dog scratches, bites, wounds to humans or to other dogs, viruses, and the transmission of disease.
<u> </u> Initials	IF, IN HCDC'S JUDGMENT, THE DOG REQUIRES IMMEDIATE MEDICAL CARE AND WE ARE UNABLE TO REACH THE OWNER OR THE EMERGENCY CONTACT, HCDC WILL TAKE THE DOG TO ITS ON-CALL VETERINARIAN HOSPITAL. OWNER AGREES TO BE SOLELY RESPONSIBLE FOR THE PAYMENT OF ALL MEDICAL BILLS FOR THE DOG AND OWNER RELEASES HCDC, ITS OFFICERS, DIRECTORS, AGENTS, VOLUNTEERS, AND EMPLOYEES OF AND FROM ANY AND ALL RESPONSIBILITY FOR, OR CLAIMS, DAMAGES, DEBTS, ARISING OUT OF OR RELATED TO SUCH MEDICAL CARE, INCLUDING, BUT NOT LIMITED TO, TRANSPORTATION TO/FROM THE VETERINARY CLINIC AND CHOICE OF VETERINARIAN AND ANIMAL HOSPITAL.
<u> </u> Initials	Owner understands that each time the Dog is brought to HCDC, that Owner is re-certifying that the Dog is in good health and has not had any communicable illnesses of any kind for 30 days prior to the drop-off. Owner acknowledges and is aware that vaccines do not protect against all communicable illnesses that may affect a dog. OWNER UNDERSTANDS THAT VIRUSES CAN BE AIRBORNE AND WILL NOT HOLD HCDC LIABLE IN THE EVENT THE DOG BECOMES ILL DUE TO A VIRUS.
<u> </u> Initials	Owner agrees to release, indemnify, and hold HCDC and MALBRIG & Associates, Inc. harmless from any and all manner of damages, claims, loss, liabilities, costs or expenses, causes of actions or suits, whatsoever in law or equity, (including, without limitation, attorney's fees and related costs) arising out of or related to the services provided by HCDC, except which may arise from the sole gross negligence or intentional and willful misconduct of HCDC, including, without limitation, (i) any inaccuracy in any statement made by Owner or information provided by Owner to HCDC, (ii) the Dog, including but not limited to destruction of property, theft, dog bites, injury, and transmission of disease, and (iii) any action by Owner which is in breach of the terms and conditions of this Agreement.

THIS AGREEMENT COVERS THE CURRENT RELATIONSHIP BETWEEN HCDC AND OWNER. EACH TIME OWNER BRINGS DOG TO HCDC, OWNER AFFIRMS THE TERMS OF THIS AGREEMENT, AND THE TRUTHFULNESS AND ACCURACY OF ALL STATEMENTS OWNER MAKES IN THIS AGREEMENT.
